
# How We Help Businesses Succeed






# How the Latest Changes May Impact Your Practice

In preparation for the new E/M changes, a large hospital system (with more than 6,000 physicians in all specialties) partnered with AAPC Audit Services to apply the 2021 criteria to their current documentation audits — and learn whether the E/M level remained the same, went up, or went down.

AAPC performed three different audits spanning July 2020 - July 2021 and monitored results closely. In advance of each of the audits, rigorous clinical documentation training — based on the 2021 EM requirements — was provided to their physicians and other non-physician providers. For each of the audits, every provider received individual results for their 2021 E/M accuracy. In addition to the individual provider impact, AAPC provided a summary of the overall E/M comparison and financial impact by practice, which assisted the organization in knowing which providers and/or practices to focus additional trainings and root cause analysis.
